CENTRAL SUPPLIER DATABASE ROADSHOW : PROVINCIAL TREASURY

Development in terms of Municipal Supply Chain Management prescripts require that all prospective and current suppliers must be registered on the National Treasury Centralised Supplier Database (CSD).

Registration on the CSD is via the following website: <https://secure.csd.gov.za/>

With effect from **1 July 2016**, Karoo Hoogland Municipality must use and verify a supplier's registration on the CSD. Therefore, you are required to please comply and register on the CSD if you are not already registered.

Failure to register may result in Karoo Hoogland Municipality not being able to conduct business with your company/entity.

In December 2016 and June 2017 Provincial Treasury visited Williston and assisted suppliers to register on the CSD.

All Suppliers (registered and not yet registered) are invited to the **Third Central Supplier Database Roadshow** that will be represented by Provincial Treasury in Williston on

1 November 2017 (Wednesday) at the **Williston Municipal Boardroom**
from **14H00 until 16H00.**

The following would be amongst the required information to bring with you:

- **Supplier information:** Supplier type, ID number, supplier name, trading name, country of origin
- **Supplier contact:** preferred contact person, preferred communication method, email address, cell phone number, telephone number, etc.;
- **Supplier address:** country, province, municipality, city, suburb, ward and postal code;
- **Bank account information;**
- **Supplier tax information;**
- **Ownership information:** name and identification number of directors, members, etc.;
- **Association to any other suppliers:** branch, consortium member, etc.;
- **Commodities** the supplier can supply

A valid email address, identity number, cell number and bank account details are mandatory in order to register on the CSD.

Please ensure that a representative from your company/organisation will be present at this roadshow for all Central Supplier Database related queries and assistance.
