NOTICE IN TERMS OF SECTION 33 & 116 (3) OF THE LOCAL GOVERNMENT: MUNICIPAL FINANCE MANAGEMENT ACT, 2003 (ACT 56 OF 2003) FOR THE PROPOSED AMENDMENT OF THE EXISTING MUNICIPAL INFORMATION SYSTEMS AGREEMENT.

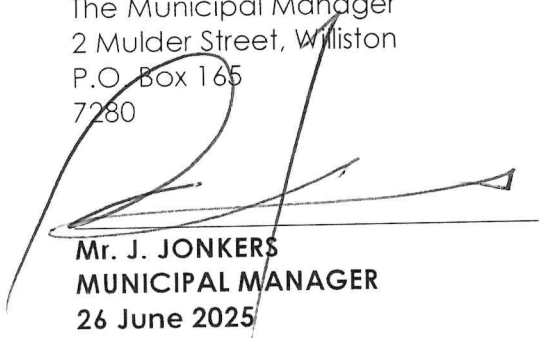
Notice is hereby given in terms of section 33 & 116 (3) (a) and (b) of the Local Government: Municipal Finance Management Act, 2003 (act 56 of 2003) that it is the intention of Karoo Hoogland Municipality to amend the existing Main agreement with the service provider for *Municipal Information Systems*. The proposed amendment of the main agreements is to provide for the extension of the services ending 30 June 2025 and enter into a further agreement for the next 10 years period. This contract will impose financial obligations on the Municipality for a period longer than the three years covered in the budget (Medium Term Revenue and Expenditure Framework) from the financial year 2025/2026 onwards.

The intent is to provide the community with insights to these systems, their current use and monetary value, measured against replacing these systems or to invoke Section 116 of the Municipal Financial Management Act (MFMA).

Notice is hereby further given in terms of section 21 of the Local Government: Municipal Systems Act, 2003 (act 32 of 2000) that the local community and affected parties are invited to submit comments or representations on the proposed amendment of the agreements. Such comments or representations must be submitted **by not later than Monday, 28 Jul 2025 at 12:00**. Copies of the draft contract and information statement summarizing the municipality's obligations in terms of the draft agreements are available for inspection at Karoo Hoogland Local Municipality offices.
