Karoo Hoogland Municipality hereby invites suitably qualified and experienced service providers to submit written quotations for:

INSTALLATION, AD HOC MAINTENANCE AND MONITORING SERVICES FOR ALARM SYSTEMS FOR A PERIOD OF TWELVE (12) MONTHS

The following conditions will apply:

- Late quotations will not be accepted.
- Price(s) quoted must be valid for at least 90 days from closing date of quotation.
- Price(s) quoted must be firm and inclusive of VAT.
- Delivery must take place within 7 days after receipt of an official order, unless otherwise stated.
- This quotation will be evaluated in terms of the 80/20 preference points system as stipulated in this RFQ.
- Quotations are subject to the Preferential Procurement Regulations, 2022.
- The successful bidder will be the bidder scoring the highest points, unless objective criteria justify otherwise.
- Payments to the successful provider will be processed within 30 days after receipt of a valid tax invoice for goods and/or services rendered to the satisfaction of the municipality.
- Failure to comply with the requirements of this RFQ may invalidate the quotation submitted.

1. Background

The Municipality intends to appoint a suitably qualified service provider for the installation (where required), monitoring, ad hoc maintenance and repairs of alarm systems for a period of twelve (12) months.

The services will be required at three (3) areas within Karoo Hoogland Municipality.

The Municipality currently has existing alarm systems installed at various municipal sites. The appointed service provider will be required to assess the existing alarm systems and provide the necessary services to ensure effective monitoring, maintenance and security functionality.

Where existing alarm systems are considered by the Municipality to be functional, suitable and compatible with the required monitoring services, the Municipality reserves the right to retain such systems and make use of the existing infrastructure.

Where existing alarm systems are outdated, unsuitable or require replacement, the appointed service provider must provide for the removal and replacement of such systems.

The final decision regarding the retention or replacement of existing alarm systems will be determined by the Municipality.

2. Scope of Work

The successful service provider will be required to provide the following services:

- Assessment of existing alarm systems at municipal sites;
- Installation of new alarm systems where required;
- Removal and replacement of existing alarm systems where deemed necessary;
- Monitoring of alarm systems for a period of twelve (12) months;
- Responding to alarm activations and system signals;
- Providing technical support and fault diagnosis;
- Performing ad hoc maintenance and repairs as and when required;
- Supplying and replacing parts/components where necessary, subject to approval;
- Providing service reports for all maintenance and repair work performed.

Important Condition:

Bidders must submit pricing for:

1. Installation and replacement of alarm systems where required;
2. Monthly monitoring services for a period of twelve (12) months;
3. Ad hoc maintenance, repairs, call-outs and technical support.

All work must be approved by the Municipality prior to commencement.

3. Contract Period

The contract period will be for a period of twelve (12) months commencing from the date of appointment.”

No automatic renewal will apply unless formally extended or re-advertised in accordance with applicable SCM regulations.

4. Pricing Structure

Bidders must submit a detailed price quotation.

A. Installation / Replacement of Alarm Systems

Bidders must provide pricing for:

- Removal of existing alarm systems where applicable;
- Supply and installation of replacement alarm systems;
- Installation of additional equipment where required;
- Labour and related installation costs.

B. Monitoring Services

Bidders must indicate:

- Monthly monitoring cost;
- Monitoring services for a period of twelve (12) months.

C. Repair and Call-Out Services

Bidders must provide pricing for:

- Hourly labour rates (normal working hours);
- Overtime rates (if applicable);
- Call-out fees per incident/visit;
- Travel and/or kilometre charges (if applicable);

Any other costs necessary for the successful completion of the required services.

No additional costs will be considered unless approved by the Municipality prior to the commencement of such work.

Bidders must ensure that their pricing is complete and includes all costs required to perform the services at the identified sites within Karoo Hoogland Municipality.

5. Payment Terms

Payment will only be made for services actually rendered and approved by the Municipality.

All work must be supported by:

- An approved official purchase order;
- Service report;
- Relevant supporting documentation.

No payment will be made for unused or standby services.

6. Evaluation Criteria

Bids will be evaluated based on:

- Price (80/90 points, as applicable);
- Functionality / experience in alarm installation, monitoring and maintenance services (10/20 points).

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.2 Either the 90/10 or 80/20 preference point system will be applicable in this tender. The lowest/ highest acceptable tender will be used to determine the accurate system once tenders are received.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and
- (b) Specific Goals

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) “tender” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “price” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “rand value” means the total estimated value of a contract in Rand, calculated at the

- time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

- 4.1 In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2 In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of-

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.
